**Candace first entered foster care around age 2.** Eventually, her parents had their rights severed, and she was later adopted. Because of so much upheaval in her short life—she started to act out. Her behaviors became too much for her adoptive family, so they dissolved the adoption. **Since that time to age 13, she's been in 19 different foster homes.**

With Candace's future uncertain, she was placed in a residential treatment center. At the center, she worked with staff to manage and express her anger in healthy ways. After a lot of hard work, **Catholic Charities staff helped to place Candace in a therapeutic foster home.**

**A therapeutic foster family provides a safe and compassionate home environment for traumatized children.** Therapeutic foster parents take on the role of a behavioral health provider, as they help children learn healthy expression and coping skills.

Now, Candace is doing well in a therapeutic foster home and learning how to function in family dynamics. **She's on her way toward finding a permanent home as she continues to thrive as a teenager.**

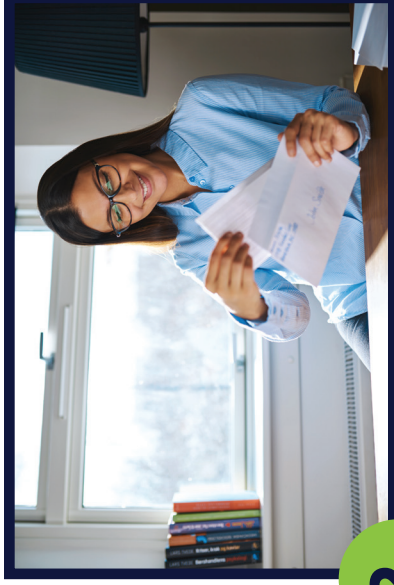
## HOW IT WORKS



1.

### Send Your Gift

Direct up to \$1,000 (filing jointly) or \$500 (filing singly) to **Catholic Charities** by **check, online** at **CatholicCharitiesAZ.org/taxcredit** or call **602-650-4887**.



2.

### Fill Out Simple Forms

Fill out an **AZ Form 301 and 352** and **file with your taxes**. You can get these forms from your tax preparer or from the State of Arizona.



3.

### Receive a Credit

on your taxes for the **full amount of your donation** up to \$1,000 (or \$500 filing singly). You can take this with the Charitable Giving, Private School and Public School tax credits.

You can get an Arizona tax credit for up to **\$500 (single) and \$1,000 (joint)** with Arizona's Foster Care Charitable Giving tax credit when you give financial gifts to Catholic Charities before the April filing date. Because more than 50% of our budget goes towards programs for children in foster care and the families that support them, **ALL** of Catholic Charities can benefit. So no matter which program of Catholic Charities you love, your gifts can qualify!
