Ric is a client of The Loft, our day center serving homeless individuals and families in Cottonwood.



We raised \$100,804 and pledges continue to come in.

The path to hope begins here


It is a simple commitment. It is everything to those who come to us in dire need. A single mother may be fleeing an abusive situation and needs shelter and counseling. A family from Bhutan may be welcomed to America and needs help acclimating and becoming productive members of their new community. A hard-working father may have lost his job and is struggling to provide for his family with no income and no benefits. Children may have been removed from their home for their protection and need loving foster families to nurture them. A young woman may be pregnant and not know what to do.

These are just a few of the examples of the need we see. Everyday. No matter their story, no matter their faith, background or ability, we meet them wherever they are on their path in life and help them to chart their own course to a better future.

We shelter the homeless and abused. We protect and nurture children. We strengthen families. A young mother struggling to make ends meet learns to budget, build her skills and resources, to plan for a better life and to work her plan with caring mentors. A homeless father finds shelter with his family and they support each other as they learn to advocate for themselves and transition into a stable situation. A homeless veteran is welcomed into a day center where he takes a hot shower, does laundry, prepares a hot meal and uses a computer to find work.

Our dedicated staff and passionate volunteers allow us to offer more than 30 programs in a service area that covers 67,000 square miles. It is their hands that do God's work in fulfilling our mission. And what we don't provide directly, we provide through referral, partnership and collaboration.

We strive to achieve a collective impact by bringing together government, nonprofits, private citizens, healthcare, businesses, and faith-based and civic organizations to strengthen those we serve and the community. Together, we are building paths to hope... paths as unique as each of those we serve.

Kathleen and Ed were about to be evicted. They were physically, emotionally and financially drained, but Catholic Charities helped them chart a new course and now they are on their path to hope.

Kathleen & Ed's Path to Hope

"I was surprised how quickly it can happen," Kathleen remembers. "I was always ahead of my situation, I made enough money. I was healthy. Then Ed was injured and I got sick."

That's when things changed, and quickly. Kathleen and her husband Ed were about to be evicted. The struggle to keep up had become too much emotionally,


physically and financially. Ed became disabled a few years ago when the seat he was buckled in was ejected through a car window. Medical costs wiped out Kathleen and Ed's savings. Kathleen tried to keep them afloat, working fulltime and caring for Ed. But, the stress finally took a toll on her health. Kathleen collapsed. Then she was laid off and lost their health benefits.

Kathleen turned to Catholic Charities for help. We prevented their eviction. Through our EmpowerU program, we helped them to take control of their finances and to live within their fixed income. Today, Kathleen and Ed have paid down much of their debt. They feel much better about their situation and are saving to buy a home. Kathleen volunteers with our free income tax assistance program, helping others in need to find their path to hope.

"It was like being in a barrel going over Niagara Falls and all of the sudden there was a net," said Kathleen. "It was like God reached out His hand and that hand was Catholic Charities." Ed added.
